



MULTNOMAH COUNTY BRIDGE TOUR LIABILITY, PERMISSION, AND MEDICAL RELEASE FORM

I. BRIDGE TOUR EXPLANATION:

Multnomah County's Department of Environmental Services, Transportation Division recognizes the public's interest in the bridges that cross the Willamette River and that a tour of a drawbridge can be an educational and fun experience for young and old alike. To serve this interest, the County has authorized limited tours of the Morrison Bridge. In order for your child to participate in the bridge tour you must read and sign this release.

Your child's safety during the upcoming tour is the highest priority for the tour guide. With this in mind, there may be areas of the bridge your child will not be allowed to tour. Your child will be required to stay with the tour guide during the tour. Please instruct your child in advance of the tour to stay with the tour guide and to follow all instructions.

Your child will be required to wear adequate foot protection. Proper shoes, that cover the entire foot, must be wom. No high heels or sandals are allowed. Your child must have on close fitting clothing, as loose clothing may catch on extending objects. Although work areas are regularly monitored and cleaned, they may on occasion become dirty or greasy, and care should be taken when walking through such areas.

In case of an emergency on site, the tour guide will explain the procedures to follow BEFORE THE TOUR STARTS. Please instruct your child if he/she does not understand the safety procedures to ask the tour guide to explain.

Please instruct your child that on the tour he/she may notice various "Danger," "Warning," "Caution," or other like warning signs around areas or equipment. Your child must not remove or cross any warning system. The warning is placed there to protect your child, as well as our employees on site.

Scuffling, horseplay, and practical jokes are prohibited. This is an easy way for people to get hurt.

The tour guide is not an employee of Multnomah County.
